Award notification	Typically, at least 6 months after sponsor deadline.

	<ul style="list-style-type: none"> <li>✓ Must contain a separate section within the description labeled “Broader Impacts”, which must appear as a heading on its own line.</li> <li>✓ No URLs should be used</li> <li>✓ Description of the work to be performed by any subawards should be included.</li> <li>✓ Results from Prior NSF Support is required (up to 5 pages of the 15 page Project Description)</li> </ul>

		<ul style="list-style-type: none"> <li>○ Must include all NSF funding regardless of whether there is salary or whether the project is directly related to the proposal.</li> <li>○ Add information for any current NSF funding (including no cost extensions) or any award with an end date in the past 5 years. If more than one award, only need to report the one most closely related to the project.</li> <li>○ Required for each PI and Co-PI regardless of whether the support was directly related to the proposal or not.</li> <li>○ Must include following information: <ul style="list-style-type: none"> <li>▪ NSF award number, amount &amp; period of support</li> <li>▪ Title of project</li> <li>▪ Summary of Results. Description of Intellectual Merit and Broader Impact activities must be separately described <i>under two distinct headings</i></li> <li>▪ Complete bibliographic citation for each publication in either the Results from Prior NSF Support section or in the References Cited – if none, state “No publications were produced under this award”.</li> <li>▪ Evidence of Research Products and their availability</li> <li>▪ If proposal is for renewed support, a description of the relation to completed work</li> </ul> </li> </ul>

		<ul style="list-style-type: none"> <li>✓ As a general policy, NSF limits the salary compensation requested in the proposal budget for senior personnel to no more than two months of their regular salary in any one year (2 person months).</li> </ul>

		<ul style="list-style-type: none"> <li>✓ Must define and consistently apply UNT’s definition of a “year” (GCA has standard statement)</li> </ul>
8	<input type="checkbox"/>	<b>Facilities, Equipment, &amp; Other Resources</b> – no page limit
		<ul style="list-style-type: none"> <li>✓ See <a href="#">PAPPG II.D.2.g.</a> for content requirements</li> <li>✓ If no facilities, a statement to that effect should be uploaded</li> <li>✓ Should not include any quantifiable information</li> <li>✓ Any substantial collaboration with individuals not included in the budget should be described in the Facilities, Equipment and Other Resources section. <ul style="list-style-type: none"> <li>○ Collaboration Letters should be provided in the Supplementary Documents section.</li> </ul> </li> </ul>

		<ul style="list-style-type: none"> <li>✓ Required for all PIs/Co-PIs/Senior Personnel (<a href="#">PAPPG II.D.2.h.(i)</a>)</li> <li>✓ Must be created through the use of <a href="#">SciENCv</a>. <i>Biosketches generated through SciENCv should not be edited after downloaded. If edits are needed, changes should be made in SciENCv and biosketch should be regenerated.</i> <ul style="list-style-type: none"> <li>○ Professional Preparation – including postdoctoral and fellowship training</li> <li>○ Appointments, beginning with current appointment</li> <li>○ Products (10 total- 5 products closely related and 5 other significant products)</li> </ul> </li> <li>✓ No Personal information should be included</li> </ul>

		<ul style="list-style-type: none"> <li>✓ Required for all PIs/Co-PIs/Senior Personnel (<a href="#">PAPPG II.D.2.h.(iv)</a>)</li> <li>✓ List of up to five distinct examples that demonstrates the broader impact of the individual’s professional and scholarly activities that focus on the integration and transfer of knowledge as well as its creation.</li> </ul>
<b>13</b>	<input type="checkbox"/>	<b>Mentoring Plan (if applicable)</b> – 1 page limit <b>*Updated Document Requirements*</b>
		<ul style="list-style-type: none"> <li>✓ Required if funding is requested to support postdocs or graduate students (<a href="#">PAPPG II.D.2.i.</a>)</li> <li>✓ Describe the mentoring that will be provided to all postdoctoral scholars or graduate students supported by the project, regardless of whether they reside at the submitting organization, any subrecipient organization, or at any organization participating in a simultaneously submitted collaborative proposal. <i>Note New Annual Award Certification Requirement regarding <a href="#">Individual Development Plans</a> for each postdoc/graduate student that has substantial support (1PM+) under the NSF award.</i></li> </ul>

		<ul style="list-style-type: none"> <li>✓ Describe how the proposal will conform to NSF policy on the dissemination and sharing of research results. For full content requirements see <a href="#">PAPPG II.D.2.i.</a></li> </ul>
<b>15</b>	<input type="checkbox"/>	<b>Other Supplementary Documents (If applicable)</b>
		<ul style="list-style-type: none"> <li>✓ Letters of Collaboration - If applicable, 1 page limit – single sentence format <ul style="list-style-type: none"> <li>○ “If the proposal submitted by Dr. [insert the full name of the Principal Investigator] entitled [insert the proposal title] is selected for funding by the NSF, it is my intent to collaborate and/or commit resources as detailed in the Project Description or the Facilities, Equipment or Other Resources section of the proposal.”</li> <li>○ The letter(s) should NOT include a personal endorsement or recommendation of the investigator and must only state the intent to collaborate.</li> </ul> </li> <li>✓ Please note that letters of support for the PI are <b>not permitted</b> unless required by a specific program solicitation.
